Plans for observing on June 24th to 28th next, the 300th enniversary of the founding of our Westcott family in America, are progressing even more encouragingly than had been expected. Arrangements thus far, vouchsafes this tercentenary celebration assuming proportions which will make it stand out as one of the most unique

and interesting of old family events. In Salem, Boston and Rhode Island, there is evidence already that public officials will give their fullest cooperation in making the occasion one long to be remembered by every visitor - and it is believed there will be several hundred of them.

A number of prominent speakers will deliver the addresses, chief among whom will be the Rev. Arthur W. Cleaves, D. During the celebration, the motorcade will visit in addition to the places of historical interest in and about Salem and Providence, historic Lexington, Concord, Cambridge, Bunker Hill, Boston, Hingham, Plymouth, Old Warwick, Pawtuxet Falls, Wickford, Coventry, Narragansett Pier, Jamestown and Newport, and also possibly, Provincetown on Cape Cod.

With 47 present, the Rhode Island Chapter, No. 2, of our Society RHODE held its first annual meeting on June 23rd last, on the farm near Provi-ISL/ND dence, of Dr. Niles Westcott. This cld farm has been continuously owned CHAPTER by the ancestors of Dr. Westcott since the year 1700. The weather was REUNION "the ideal Westcott-reunion kind." After discussing the affairs of the Chapter, which, reports showed, are in a flourishing condition, a history of the old farm and its owners, was given, and this was followed by an outline of the plans for next year's celebration of the general family. At the conclusion of the program, the kindred went into a huddle with their basket suppers, coffee being served by the gracious hostess. The ancient family burial ground nearby was visited. Great credit is due to Dr. and Mrs. Westcott for the splendid condition in which the grounds are kept. Some of the graves date back to 1749. The day following the reunion - Sunday forty of those present attended services in the old First Baptist Church at Providence. The pastor, the Rev. Arthur W. Cleaves, D. D., took for his subject: "What Our Ancestors Have a Right to Expect of Us," and during his discourse, referred to Stukely Westcott and his descendants, of whom those present were asked to stand that they might be identified. The church calendar contained this notice: "The Church is honored this morning by the presence of a group of the descendants of Stukely Westcott, who was one of the twelve men with whom Roger Williams shared the site of Providence. He was one of the original members of this church, having been baptised in 1638." V. Stukely Westcott, 22 Cooke Street, Pawtucket, R. I., is President of this Chapter.

Seventy of the Westcott kindred of northern New York, including UP-NORTH ten members of our national Society, assembled at Westcott Beach, WESTCOTTS near Sacket Harbor, N. Y., on August 27th, to "know their kindred ORGANIZE. better." Ideal weather, ideal surroundings and ideal spirit on the part of everyone . present, made it an occasion long to be remembered. Allan F. Westcott, president of our Society, who is spending his summer holidays near his native Alexandria Bay, was master of ceremony, and the host and hostess was George H. Westcott and wife, owners of the beach. Baskets and hampers revealed abundantly ye olden tyme ability of Westcotts to appease their appetites, coffee being served from the urns of the gracious hostess. Following luncheon, the family gathered, and after listening to an outline of the family history and the current organized activities, voted to form an association and apply to the national Society for a charter for a Northern New York Chapter. The following officers were elected: Frank N. Westcott of Watertown, president; J. F. Westcott of Lacona, vice-president, and Mrs. Hollis Westcott of Chestnut Ridge. sccretary and treasurer. It was decided to hold reunions every year, the place and date in 1935 to be decided by the officers. The Westcotts of northern New York descend chiefly from Gardiner and Mary (Knight) Westcott, natives of Rhode Island, who after living a short time at Cheshire, Mass., settled at Deerfield (new North Utica, N. Y.) about 1793. Ten years later, with the majority of his eleven children, Gardiner removed to near Sacket Harbor where he died in 1808. He had over seventy grandchildren. When the English attacked Sacket Harbor in 1813, Caleb Westcott, son of Gardiner, almost singlehanded, held the invaders back until the American troops could arrive. A colonel of the troops was John Westcott, another son. The Westcotts therefore, are justified in the pride they hold in their beautiful and glorious north-country.
