This issue of "The Quarterly" is accompanied by two pages of the "Westcott Genealogical Bulletin." The Society has been highly commended by libraries, genealogical and historical societies and some owners of the Westcott genealogies, for the continuance of family research and furnishing the results in these quarterly bulletins. "It is an appreciated innovation in family history," writes one society, "and worthy adoption by other family associations."

Only routine business was transacted by the Directors in annual meeting on Jan. 10th. Miss Rachel C. Wilkins extended an invitation from the Vermont Chapter to hold the Fifth Biennial Celebration of the Society at Poultney, Vt., in 1943. The invitation was much appreciated, but due to the present troubled condition of the country and the uncertainty of the future, it could be accepted only tentatively. The report of the Secretary showed that twenty-one new members were received during 1941, giving a total of more than 200 descendant members. The report of the Treasurer showed the Society had a bank balance of \$90.70. The following Directors were present: Dr. F. Howard Westcott, Dr. Allan F. Westcott, Joseph R. Westcott, William G. Westcott, Pliny K. Westcott, Roscoe L. Whitman, Mrs. Adelbert N. Potter and the Misses Ethel Clarke and Rachel C. Wilkins.

Miss Ethel Clarke, who has been the efficient Secretary of this Society since its inception in 1934, has resigned, effective Jan. 10, 1942. With eight years of faithful service to her credit, she is entitled to a well-earned rest, and the thanks of every member of the Society for her ever-loyal and enthusiastic attention to her duties as Secretary are extended to her.

In accordance with the provision made in the "Articles of Organization", President F. Howard Westcott has appointed another charter member, Mrs. Adelbert Niles Potter, 25 Fifth Avenue, New York City, to fill the vacancy caused by the resignation of Miss Clarke. The years of business experience of Mrs. Potter especially qualifies her to capably fill the position, and no doubt, all of our members will give her the fullest support and wish her luck. Mrs. Robert Zimmerman has been appointed Recording Secretary.

The ninth annual dinner of the Greater New York Chapter at the Fifth Avenue Hotel on January 10th, was greatly enjoyed. Due to the near-zero weather, ice and snow, only thirty-seven were present, among them Mr.* and Mrs. Edgar E. Greene of Palisade, N. J., Mrs. Clarence H. Wescott and daughter, Miss Elizabeth May Wescott of East Orange, N. J., and William Cardner Westcott of Scranton, Pa., who were present for the first time. The guest speaker was the Hon. William M. Beard, who, with Mrs. Beard, came from Westfield, N. J. He made an interesting and timely talk on the American Constitution. Past-President Allan F. Westcott, who, with Mrs. Westcott, were present from Annapolis, Md., read a copy of a letter written a long time ago, by a Miss Mary Wescott, describing her visit in the household of President

IN MEMORIUM. Our charter member Anson Francis Beardsley of Ogwego, N. Y., died September 5th, 1941 (A-252). He was one of our older members, but always keenly interested in the family activities. -- Our charter member, Harris Lee Cooke of Cooperstown, N. Y., passed away December 10th (G-266). He appointed the committee which Jan. 13th, 1934, organized this Society. --Frances Clark Morris (Mrs. Clarence Sextus*) of Milford, N. Y., died December 20th, (G-298). She was chairman of the entertainment committees at the Westcott reunions in 1931 and 1933 when initial steps were taken in organizing this Society. --Randall Westcott of Jerome, Mich., died December 17th (A-405). He was deeply interested in the Michigan Chapter, of which he was a Vice-President. --Our member, Flora Ellen Westcott, of Norwich, N. Y., died January 2nd (A-159). She was a Westcott in her own right and widow of James Herbert Westcott. --Daniel Clark Lewis of Millville, N. J., passed away last September 24 (A-142). He had been an interested Associate Member of this Society since 1935. --The sympathy of the Society is extended to the members of all the families of the deceased.

Until recently, the only known members of the Westcott family to come to America. were Stukely Westcott and his nephews, Richard, William and Daniel, and his sister, Rebecca (Cooke, A-393), all first settling in the Massachusetts Bay Colony. The nephew William, was thought to have been a merchant mariner, leaving Wethersfield, Conn., where he is recorded in 1636 (A-394), and appearing in Westmoreland County, Virginia, in or before 1683, the year of or shortly following his death (A-400).

It has been thought this William became the progenitor of a considerable family in 2 Virginia. At the time of his death, he had a married daughter, Mary, and possibly a son, John, born in 1659. However, professional genealogists employed by our member Miss Mary Wescott of Durham, N.C. (A-401) and a recently enrolled member, Miss Elizabeth May Wescott of East Orange, N. J., have found, among many Wescott records in Virginia, one of a Margaret Foote Wescott, widow of Anthony Wescott, with daughter Agnis and probably son Giles, mentioned in the will of Johan Foote dated Dec. 27, 1647. William Westcott, the nephew of Stukely Westcott, was not born before 1613, and therefore, could not have been the father of Anthony Wescott, who, deceased in 1647, had married and had a daughter and probably a son. Therefore, it may be assumed Anthony was born probably in England not later than 1620, some seven years after the birth of William Wescott. As no record has been found of Anthony in New England, it appears likely he emigrated directly to Virginia and that from him descends at least some of the Wescott family in and from the South. George Wescott, known as the wealthy "coppersmith of Philadelphia", was probably one of them. His family, according to family tradition, were "tories or Loyalists, as they called themselves", and this is indicative of his nativity. He was witness to a will in 1744. Mary and Elizabeth Wescott, mentioned in the old letter describing their experience as guests at Mt. Vernon in the household of President and Martha Washington (which letter was read by Dr. Allan F. Westcott at the family dinner last January in New York), were daughters of George Wescott. His son was Robert Wescott to whom Washington presented a sword for service following the Revolution. This Robert was the great-grandfather of our members, Miss Elizabeth May Wescott of East Orange, N.J., and Albert Lothridge Wescott of Leonia, N. J .-- and so it is found that the Westcotts of New England were not the only Westcotts (or Wescotts, as the Virginians spelled the name) in America in the early 17th century.

Miss Susan Westcott Handy and National Chaplain William Mar Westcott of the committee whose members annually place a wreath at the tablet at Warwick, R. I., memorializing the memory of our Family Founder, performed their duty on January 12th, anniversary of his death, in spite of the sevene weather at the time. Miss Handy read an appropriate poem and prayer was offered by Chaplain Westcott.

One of our charter members, Edmund Whitman Morris, was inducted into the army on January 22nd. With victory accomplished, it is hoped to see him back soon at the family table. "The Quarterly" would like to know of any other member or members who are now with the colors.
