MORE KINDRED--The newspapers recently said that "Roosevelt and Dewey were cousins;" that their "relationship traces back to Hepzibal Lyman of Northampton, Mass., who married the first Dewey to come here in 1630." Now let the Westcott genealogist speak: Josiah was not the first Dewey to come here. His father, Thomas Dewey, came here in 1630, and his son Josiah, was not baptised until 1641. (Westcott Genealogy, vol. I, pp. 328-9.) A member of the S.S.W.D. sits down to this table of kinship. Josiah and Hepzibal Lyman Dewey had among their children, a son 2-John, who had a son 3-Jonathan, and then came 4-Aaron, and 5-Aaron, Jr. This younger Dewey had a daughter 6-Johanna who married Eli Rose, Sr. (W.G., vol. I, pp.360-1), and to them was born a daughter 7-Wealtha, who married Reuben Westcott, Jr. of Milford, N. Y. (W.G., vol I, pp.112, 288.) They were the great-grandparents of this genealogist and many other members of this Society. And, so be it!

RHODE ISLAND EXPECTS YOU NEXT JUNE -- The first National Celebration of the Society of Stukely Westcott Descendants was held in Rhode Island ten years ago, June, 1935. Now, our cousins living in the original Westcott homeland in America expect Westcott descendants to return next June. The gathering in 1935 was a notable commemoration of the 300th anniversary of the coming to America from England of the patriarch of this branch of the Westcott family, Stukely Westcott, with his wife and six children. The second biennial celebration was held two years later (1937) at Cooperstown, N.Y., famed as the home of James Fenimore Cooper. Then, in 1939, the third celebration was held at Bronxville, N.Y., at the time of the World's Fair. In 1941, historic Alexandria Bay in the Thousand Islands was the scene of the fourth celebration. Owing to the war, the fifth celebration was not held in 1943 as scheduled, but the Greater New York Chapter was host to the Society at its dinner-meeting in New York last January. This event was also in recognition of the tenth anniversary of the founding of the Society. The five celebrations were all well attended and enjoyable. Now, thoughts of Westcotts again turn to Rhode Island and the Sixth Biennial Commemorative Celebration. The Chapter in Rhode Island has a committee making plans and preparations, details of which will be announced in "The Quarterly" for March next. It is not too early to begin making YOUR plans and preparations to attend.

MORE WESTCOTT HORSEMEN--Mention was made in "The Quarterly" for September of four Westcott men who owned trotting horses, some of whom were aactive in racing them. Mrs. George Washington Wescott, our member of Sumner, Iowa, has a copy of "The Bulletin-Journal" of Independence, Iowa, of Sept. 23, 1943, in which mention is made of race meets on the local "driving track" in August, 1891, and August 1892. In 1892, the special event was Nancy Hanks, one of the famous horses of the period, to beat $2:07\frac{1}{4}$, which she did by establishing a world record of $2:05\frac{1}{4}$. At this meet, George Washington Wescott of Sumner (A-147*, had an entry, a trotter of considerable note. His son, James Monroe Wescott, also owned trotters, Both father and son attended race meets throughout the state. They were the grandfather and father of the late George Washington Wescott (A-147), and it is through the kindness of his widow that "The Quarterly" is able to give this added information of Westcotts who owned fast horses a half century and more ago.

IN MEMORIAM--William Robert Morrison of Westfield, N. J., husband of our member, Gladys Salt Morrison (G-150), and father of our member, Helen Margaret Morrison, and John Charles Morrison, U. S.
