THE 7th BIENNIAL CELEBRATION AN OUTSTANDING SUCCESS.

Members of the Society who haven't attended one of the biennial family celebrations, can hardly realize the enjoyment they miss. This is particularly true for those who failed to attend the 7th Biennial Commemorative Celebration in old historic Johnstown in the Mohawk Valley last July.

The weather was ideal, the Hotel Johnstown was a gem for the gathering and Johnstown proved a delight with its wealth of historical incidents in the life and activities of Sir William Johnson, for whom the city was named. A printed program was mailed to all members with "The Westcott Quarterly" for June and the various events were carried out in detail with some added features.

There were forty in attendance, which considering the fact that with one exception, the nearest member lived more than fifty miles away. Friday evening was passed on the broad veranda of the hotel and many old and new acquaintances were made.

The Celebration proper began Saturday morning when ten cars carried the group to the many points of interest, including the grave of Sir William Johnson and Johnson Hall which he built in 1762 and where he died while counciling with the Indians in 1774. The old Mansion has been wonderfully preserved and is an intensely interesting exhibit of architecture in his day. One of the two stone forts flanking the mansion still stands, a grim reminder of the days when the savages were more numerous than the white settlers.

The Memorial Service

After luncheon, the group assembled for a memorial service, commemorating the founder of the family, Stukely Westcott, 1592-1677, and his descendants now deceased. The impressive service was addressed by Mrs. Angle Frelick Waugh of Fulton, N. Y. The report of the Secretary named six members who passed away since the Celebration at Providence in 1946. A silent prayer followed. President Leslie P. Westcott presided.

The Business Meeting

After a short recess, the biennial business meeting of the Society followed, with President Westcott in the chair. Reports of the officers showed the Society in a sound, flourishing condition. There was some discussion and suggestions relative to when and where in 1950 the eighth biennial celebration should be held. The Banquet

After a busy day, the group filed into the banquet hall in the evening bent on enjoying the good turkey dinner provided by Mr. Fred H. Ramsey, vice-president and manager of the Hotel Johnstown. It was one of those occasions only too rare in the history of the Society. Mrs. Charles S. Price of Clayville, N. Y., led in singing several songs during the dinner. After ice cream and coffee, chairs were pushed back and the group settled down to hear the two addresses that followed. Retiring-President Leslie Destcott introduced the first speaker, Mr. John T. Morrison, president of the Johnstown istorical Society, who traced the life and activities of Sir Villiam Johnson during his residence in Johnstown. His address was intensely interesting and illuminating. An address followed by Dr. Allan F. Lestcott of Annapolis, Md., and Alexandria Bay, N. Y. Having been elected President of the Society in the afternoon, the future of the Society was uppermost in his remarks. He counciled those present to loyally support the Society by obtaining new members and by impressing on the minds of known descendants of Stukely Westcott the facts of their rich heritage. The Rev. Malter O'Grady of Johnstown, pronounced the benediction, and then came a surprise number not on the program. Through the courtesy of Mr. Michael F. Tretola of Gloversville, whose wife was local chairman of the Jelebration, the famous moving picture, "Drums Along the Mohark," was shown. The picture was regarded as a fitting climax to the Celebration.

THE WESTCOTTS OF MILFORD, N. Y.--In August, 1933, the Westcotts of Milford, N. Y., took two steps of which they should feeljustly proud. Most worthy was their determination to reclaim an old cemetery at Milford Center where their settling forefathers were buried in the early years of the 19th century. Bushes and vines had grown during the years almost obliterating the sacred acre as a cemetery. An endowment fund was proposed. This fund now amounts to within \$140.00 of the \$2,000 goal and assures reasonably good care of the cemetery in the future. Furthermore, they proposed a national society of the Westcott family and appointed a committee to bring it about. A dinner-meeting in New York followed in January, 1934 when the Society of Stukely Westcott Descendants was organized with Dr. Allan F. Westcott of Maryland, itr first president.
