Dr. Westcott will approach all areas of his work from the viewpoint of a Dedicated Christian Layman which qualifies him for leadership in this Christian Y sponsored Marriage Counseling Course."

EARLY WESTCOTT HISTORY---Data sent by Mrs. Nettie Emery which was printed in the D. A. R. Magazine September, 1896. Volume IX No. 3.

"The Westcott Family is spoken of in the History of Devonshire, a work more than four hundred years old, as "an ancient and honorable one as far back as A. D. 1170. There are only two copies of this called "Close" of Westminster Abbey." This copy was shown to Mrs. Catherine Westcott-Komey by Bishop Foss Westcott (Lord Bishop of Durham Cathedral.) Bishop Westcott who has died, was distinguished as the author of thirty books on classical and theological subjects, and had five sons in the ministry (refer to Westcott Society Quarterly of September, 1951.) The records in the "History of Devonshire", show that the name originally was "de Westcote", taken from an estate in Devonshire, England, and this rendering of the name is still preserved by some descendants of the family in this country. "John de Westcote" the first one

in the History of Devonshire, was a man of literary taste and culture even at that early age, as he wrote a book before printing was invented which was placed in the Archives of Exeter Cathedral. A George Blagden Westcott, killed in a naval engagement off the Coast of Trafalgar, was of the same "de Westcote" family. Lord Littleton, author of "A Treatise of Tenures" which Lord Coke, according to Burke's Peerage, characterized as "The Ornament of the Common Law," and the most perfect and absolute ever written on any human science, was also born a Westcote, but had his name changed to Littleton to inherit his mother's estate and title. Lord Littleton, known as the father of English Jurisprudence, "Coke on Littleton", is an important study for law students." (To be continued in our March Issue in 1954)
