REPORT OF THE 10TH BIENNIAL GATHERING OF WESTCOTT COUSINS ---Many of our National Society members spent a very pleasant weekend in Rhode Island from Friday evening, August 6th, when they first gathered at the Sheraton-Biltmore Hotel in Providence, to Sunday evening, the 8th when cousins gathered on the spacious lawn of our dear Dr. Niles Westcott and wife, Clara at Oaklawn, Rhode Island,

The Rhode Island Chapter worked very hard to give the out-ofstate cousins a wonderful time. It was the third visit of our National Society to Rhode Island and with a state so rich in our early history there was never a dull moment. The committee was headed by Miss Susan Westcott Handy, our National Vice-President and General Chairman of 10th Biennial meeting. She was assisted by Mrs. Ansel A. The National Society wishes to express thanks for the splendid co-operation of the above committee for their excellent work in

making the gathering a big success.
On Saturday morning we left the Sheraton-Biltmore Hotel in a motorcade to Newport Historical Society where we first held our business meeting, lead by our President Dr. George Dana Pickens, and greeted by Mr. Herbert Brigham, the Librarian of the Newport Historical Society. At that time officers of the Society were elected for term of 1954-1955-1956. The officers are as follows:

A short memorial service was held for our deceased members led by Mrs. Maude Colwell in the absence of our Honorary National

Chaplain, William Marr Westcott.

At noon on Saturday, August 7th, we were guests of the Rhode Island Chapter on the lawn of the Historical Society for luncheon. After the luncheon we were taken on a tour of some of Newports' Historical points of interest, which included the Old Colony House, the Vernon House, Trinity Church, the Old Stone Mill and Arnold's burial lot. Our motorcade then made a tour of the Ocean Drive so famous for its wealthy homes.

Saturday evening, we gathered for the Clambake at Manville, some 40 miles north at "THE BREEZES", home of Miss Susan Westcott Handy and Thomas H. Handy, Junior. Robert V. Simpson and his wife were in charge of the Clambake and we later found out that Mr. Simpson is eligible to belong to our Society through Damaris Westcott Arnold line. Over sixty cousins enjoyed the "Bake", which included clam chowder, clam cakes, clams in butter, vegetables, corn, lobster and watermelon---simply delicious!

On Sunday many cousins gathered for the church service in the old First Baptist Church in Providence (which church our ancestor, Stukely Westcott helped to found with Roger Williams). Before the church service Reverend Henry Schooley, Rhode Island Chapter Chaplain gave a review of the life of our first Stukely. Later in the day the motorcade drove down to Warwick for the placing of a wreath on the marker of Stukely Westcott's lot, which marker was placed there in the early years of our National Society. Some cousins walked over to the burial place of our first Stukely some one hundred yards from the marker in a wooded area.

After the wreath dedication by Reverend Henry Schooley we drove down to Oaklawn, the home of Dr. & Mrs. Niles Westcott where we enjoyed refreshments and a nice visit with cousins and also sang some of our Westcott songs.

The "Good-byes" were hard to say, for everyone had enjoyed such a pleasant time at the 10th Biennial Gathering in Rhode Island.

All of us had missed our founder, Roscoe L. Whitman and his wife Susan. We felt he was there with us in spirit and when some of us see him on his 85th Birthday on September 25th we will tell him how much we missed him.

Having spent the winter in Florida, they had returned but two weeks before his death. Mr. Westcott was born September 28, 1877, in Potsdam, the son of Samuel Powell Westcott and Phoebe Field Westcott. Mr. Westcott attended schools in Potsdam, including Potsdam Normal. He was graduated from Albany Business College and then studied telegraphy at Rochester School of Telegraphy. He and Miss Edith McGuirm were married July 15, 1908 and that August they came to Massena and opened a store in Ball Block. He later moved his store to the Newton Block. Mr. Westcott attended Emmanuel Congregational Church and was a member of the Men's Club of that church. He was a charter member of the Massena Country Club and a member of Massena Lodge 1702, B.P.O.E. He was well known throughout the community. Generations of school children bought their books at his store. Surviving are his wife, son Arthur Westcott, a daughter Mrs. Keith (Korleen) McCullough of Massena; two grandchildren, A. Jeffrey and Judy.

EARLY WESTCOTT HISTORY---Continued from June 1954 Quarterly

"All the New Jersey Westcotts are descendants of the first colonist, "Daniel of Stamford, Connecticut" and John Westcott in the early part of the Revolutionary War removed his family from Philadelphia to the old home in Bridgton, New Jersey, and joined Sealey's brigade of West Jersey Artillery, rising to the rank of Captain. He was commissioned by General Washington, crossed the Delaware in the same boat with him (family tradition). Descendants of this line of the Westcott family have among heirlooms, a seal and seal ring bearing the shield and crest of the family, Miss Sara Lipscomb, Regent of Columbia Chapter of D. A. R. would have this seal. Also Judge Westcott or Judge D. Westcott has this seal and coat of arms. Note: the foregoing Generalogy is copied from American Monthly Magazine for September 1896 published by the National Society of the D. A. R. Volume IX, No. 3. This issue is preserved in the files of the D. A. R., Continental Hall, Washington, D. C. The Coat of Arms bears this motto: "Spe Labor Levis", meaning, "By Hope is Labor Lightened."
