Sanford H, Westcott reached his 100 years on October 7, 1958. Many of us saw him at Cooperstown in August, which he attended with his two sons. In the Washington, D. C. Evening Star there was a nice article about Sanford. The 100 year old former educator remembers that he cried when Lincoln was shot.

Sanford wears glasses for reading only and is just slightly deaf. He says about his long life, "It isn't so much what I have done; it's

what I haven't done."

He retired 40 years ago after serving 32 years in Southern Michigan schools, 24 of them as Superintendent.

He lives with his daughter, Mrs. B. E. McLaughlin, of 2724 Fort

Scott Drive, Arlington, Virginia.

EARLY WESTCOTT HISTORY --- (Continued from September Quarterly)

"Stukely's civic as well as his religious life was constantly active in the interests of the Young Colonial, and his children and grandchildren were no less faithful in this duty. He was eight times a member of the Court Commissioners from Warwick, General Assistant (Lt. Governor) of Providence Plantations (1653), many years a member of the Town Council, a surveyor for years of the land acquired from the Indians and held divers important committee appointments. He became one of the most extensive planters in the Colony, owning, at one time upward of more than seven thousand acres of land in what is now Providence County in Rhode Island and as such, took a leading part in the settling and developing of the whole section."

It was decided that, since Linda was so kind to give us the money, we should have the first plaque made for her late husband, Dr. George D. Pickens. Ths Society has ordered it.

We will run the advertisement continually for the two types of plaques, now made available to all cousins.

Tombstone Memorial Plaque: at \$24.00 each, in Bronze, measuring about 6"x9", with 4 screws to fasten on stone. The plaque includes our Coat-Of-Arms, person's name and Society name. Example: Dr. Picken's plaque read ---

Each plaque is made up individually, with our Coat-Of-Arms at the top and members name underneath.

2. Wall Plaque: Westcott Coat-Of-Arms only, \$12.00 each, suitable for hanging on wall, measuring about 5"x7" in Bronze mounted on walnut with chain for hanging.

It takes from 4 to 6 weeks to have plaques made up. Either plaque will make a thoughtful gift. In regard to the Memorial Plaque, your local mason will screw it to your family stone.

The orders for the plaque should be sent to the Secretary, so that Mrs. Trismen can keep track of the number of plaques ordered.

Rebecca Westcott---Our New Associate Member, Mrs. Frederick W. Van Orden sent the following data.

Research on the "Cook" family, by Dr. Alfred Cook, "Descendants of Thomas Cook", Part I, "The Rhode Island Cooks".

"Thomas Cook Senior, the progenitor of our family is said to have resided at the Earle's Colne, on the Colne River, some sixty miles from London. He landed at Boston, 1635; was one of the fifty-four founders of Taunton, Massachusetts in 1637; and settled on the island of Rhode Island which was called Afindneck in 1643. This island had been purchased by some company of which Ann Hutchinson, the religious agitator was a member. Some declare that our Thomas Cook, with Richard Borden and Ralph Earle, was the founder of Portsmouth Township on this island where he lived. It is a township that has no villages or hamlets. There is, however, a building on it containing a library."

It was not known, with certainty, who was the wife of Thomas Cook Senior, but some consider that she was Rebecca Westcott and a sister of Stukely Westcott, who lived in Rhode Island. After the death of his wife, Rebecca, Thomas Cook Senior, married a second wife, Mary, believed to have been a sister of Giles Slocum, a neighbor of Thomas Cook. After Thomas died Mary married Jeremiah Brown.
