LETTER---Minita Westcott Trainor of Chicago, Illinois sent the following clipping about her experience coming in on the new jet plane, Electra, the very one that crashed.

Minita, who is Executive Secretary, of the Flat Glass Jobbers Association and accompanying officials flew east to a meeting of the

association in New York City.

"The flight was made in four hours and twenty-five minutes under ideal flying conditions at 29,000 feet with a ground speed of 650 miles per hour. Much of the time the ground was visible and the speed of the flight was apparent as the width of the United States from the Pacific Ocean to the Atlantic Ocean spread out below.

This plane is a Boeing 707, with a length of 144 feet and carried 112 passengers. Mrs. Trainor on her return trip from New York to Chicago rode on the American Airlines jet powered 'Electra', which crashed in the East River on its return trip to New York that night."

Luna-Inkongo, "Travelling northeast on the main road to East Congo, we visited two of the Westcott Mission Stations. It was at Inkongo station near the Sankuru River that the Reverend W. H. Westcott and his colleagues translated the whole Bible into Luna-Inkongo.

The Tshiluba has here, as in many other areas, become the lingua franca and is used in the schools and by government circles. The luna language is thus dying out among the younger generation. It is, however, used in preaching the Gospel and the Westcott Bible has been and still is a real blessing to the older folks.

Some unbound Bibles ordered shortly after the war may at long last be found in Leopoldville and thus enable some of the older folks to have their own copy of this excellently translated Bible.

EARLY WESTCOTT HISTORY --- (Continued from March Quarterly)

"The first migrations from the homeland in Rhode Island were to Connecticut during the middle of the 18th century. However, the great spread of the family did not begin until, during and soon after the Revolution. It was then that many descendants in the fifth and sixth generations settled in western Massachusetts, Vermont, throughout the east, east-central and north section of New York and North-eastern Pennsylvania. Gardiner Westcott was the first to carry the family name west of the Hudson River, when in 1793, he settled near what is now North Utica, New York. Benjamin and James Westcott settled in Milford Township, Otsego County, New York, two years later. Several grandchildren of William and Eleanor (Westcott) Stone settled about Abbington in north-eastern Pennsylvania just before the close of the 18th century. However, in 1789, Benedict A. Robinson, a descendant, pushed on westward to Ontario County and settled in that part which is now Yates County, New York. These migrants were all with large families. Some of the lateral families were the Angells, Arnolds, Bartons, Eatons, Greenes, Hazards, Munfords, Perrys, Randalls, Staffords and Wightmans."
