There was an informal reception, registration and reservations

were taken for the clambake on Saturday.

The regular business meeting was held at Smith's Castle, Wickford, Rhode Island, on Saturday Morning, August 20th, at 10 A.M. Mrs. Marion Dorfler, our National President, called the meeting to order. In the absence of the Recording Secretary, Mrs. Bertha Anthony, acted

as Secretary pro-tem.

Mrs. William Baxter, President of the Rhode Island Chapter extended greetings and welcomed everyone to Rhode Island; hoped all would enjoy the program arranged, and invited us to her home "Wescote" on Sunday afternoon. Mrs. Dorfler greeted the members and introduced her husband and daughter. She expressed appreciation to the Rhode Island Chapter for the fine arrangements made for the Society's pleasure, especially to Sue Handy and Olive Shippee as Co-chairmen, and to Tom and Sue Handy for so graciously opening their beautiful home. Miss Leone Cargill, Art Instructor in Providence schools, was commended for the name tags she designed, a small replica of Rhode Island with the Westcott insignia in the center. Mrs. Dorfler used the black walnut gavel given to the Society, two years ago by Ralph Wescott, Treasurer of the Rhode Island Chapter, which was made from a tree branch, on the estate of our former member, Dr. Niles Westcott.

The report of the last biennial meeting was read and accepted

The report of the last biennial meeting was read and accepted with the following corrections: That Mrs. Lena Munson was the oldest member present at Cooperstown and that Mr. Sanford Westcott, a non-member, age 99 years, had attended the Saturday session. Also the report stated that Stukely Westcott's sister Mary, married Thomas Cook, Sr. Thru records in Salem, Massachusetts it was found his sister's name was Rebecca instead of Mary. This correction was made on the

minutes.

Two new chapters reported: No #9 Iowa Chapter by Mrs. Robert Perdue who was instrumental in its organization, and Greater Cleveland Chapter No. #10 by Mrs. Efflo Plazer its organizer. No representatives were present from Milford, New York Chapter, nor from Vermont. It was understood Vermont is holding its annual meeting this weekend. It was announced that the former Rachel Wilkins Baker, of the Vermont Chapter,

is now Mrs. Lisle Cottrell, of Buskirk, New York.

Rhode Island Chapter No. #2, Mrs. Alice Baxter, President, stated it has about 30 members. Four meetings have been held since the 1958 Biennial meeting in Cooperstown; a cookout at "Westcote"; a luncheon meeting in Newport; a meeting at the Old Slated Mill in Pawtucket; at which time plans were made for the National Society meeting in Rhode Island; and the last, at the quarters of the Rhode Island Audubon Society in Providence, to complete the plans. Mrs. Baxter presented a gift to our President, Mrs. Dorfler, to remember her visit to Rhode Island.

Dr. F. Howard Westcott, of the Greater New York Chapter No. #3, said a social meeting is to be held at the Knickerbocker Country Club, Tenafly, New Jersey, on Saturday after Thanksgiving, November 26th,

to which anyone interested is invited.

The Treasurer's report will be included in this Quarterly. We have a balance of \$299.58 at the present time. It was also thought wise to include in the Quarterly the minutes of this meeting so our members can read the report prior to our next meeting. Mrs. Marroquin stated that dues are now payable. Also stationery with the Westcott insignia at the top is still available; 20 sheets and 20 envelopes for 75ϕ .

Mrs. Trismen, Corresponding Secretary and Registrar, reported that as of January 31, 1960 there were 227 members in the National Society, 12 more than last year. There have been 122 deaths since 1934; 20 new members since January, 1959 including 11 reinstatements

and there have been nine deaths.

Mrs. Trismen showed a sketch of the Westcott marker placed on Roscoe Whitman's grave and dedicated in September, 1959; money for the die for same was given by Mrs. Pickens, in memory of Dr. George Pickens. These markers are for sale at \$24.00 each. A wall plaque was displayed which will sell for \$12.00. This has a little chain on the back, the insignia is mounted on black walnut. If we have a few orders for these items each year, the manufacturer will hold the die for future use. Two orders were taken for the wall plaques.

Mr. Leslie Westcott reported that here is a little question as to the early location of the burial place of Stukely Westcott, near the memorial tablet, in Warwick. He is looking up the original deed

and will report later on same.

Dr. Howard Westcott spoke of the very fine work Mrs. Trismen has done during the past few years as Corresponding Secretary and Registrar, to which everyone heartily showed agreement.

Mrs. Ralph D. Trismen, our new National President, declared the business meeting closed at 12:15 P. M. This was followed by a Memorial Service led by Chaplain William Driver; the names of our deceased members since 1958 were read and prayer offered by Mr. Driver.

Sandwiches and cakes were served by the Rhode Island Chapter. After a tour of the Castle in the morning, members made a pilgrimage to the Old Narragansett Church in Wickford, in the afternoon, also to the birthplace of Gilbert Stuart, in Saunderstown, Rhode Island, home of the artist who painted the famed portrait of George Washington; and then we returned to "The Breezes", the Handy home for a wonderful clambake. The weather was favorable and tables were spread on the grounds behind the house.

On Sunday morning, August 21st, the Society, with attendance of over thirty, attended services, at the First Baptist Meeting House, in Providence, the oldest church of any denomination, in Rhode Island and the oldest Baptist Church in America, of which Stukely Westcott was one of the original members. This beautiful church has been recently renovated at a cost of \$500,000 and its original charm restored.

Sunday afternoon a pilgrimage was made to the Memorial Tablet of Stukely Westcott, in Warwick, after which tea was served at "Westcote", the home of Mrs. Baxter, of the Rhode Island Chapter, in Oak Lawn, Rhode Island.
