## LETTER --- From Mrs. George J. Wescott

Mrs. George J. Wescott gives an item of a Nathaniel B. Wescott, attorney. It is quite a lengthy article so I will give the high lights; Nathaniel B. Wescott, son of Nathaniel Savage and Margaret (Scott) Wescott, was born on September 14, 1856, at the "Point Farm" in Upshur's Neck, Accomack County, Virginia. He studied law at the University of Virginia. He practiced law in the western states, but, because of ill health, returned to the family farm, at Hawks Nest, (Mappsburg), about 1891. In 1881, he married Leah MacAllen Powell. She was the daughter of John and Sallie (Nottingham) Powell. After a very interesting life, Judge Nathaniel B. Wescott died, in Olney, on March 18, 1930. He was survived by his widow and 5 children, one of whom was Powell Wescott, of Wilmington, Delaware.
