LETTER FROM DOROTHEA COGSWELL --- dated August 18, 1962.

Dear Eleanor, "Many thanks for your nice note. I was so sorry you couldn't be at King's Chapel." (Note - I ate something that didn't agree with me so Ralph, Alice Marroquin and I left Boston, Sunday A.M. before church). "The service was quite like the Episcopal one. Sunday morning I had phoned a cousin of mine who is Junior Warden, to tell him how many were likely to be there. He called the lay reader, and they put all of the regular parishioners on the right of the center aisle, leaving the whole left side for us. The pews are just like the Old North Church ones. They have a special, large, raised sideways pew at the far right reserved for the Governor, the President, or any visiting rulers. Queen Juliana was the last one to use it. The chalice-type pulpit is the oldest pulpit in this country which has always been in constant use; the sounding-board hanging over it used to be lowered on the minister if he talked more than two hours (one turn of the hour-glass) at a time! (The verger told us these things and many other interesting things after the service. I wish you could have heard him.)

The Satterfield family were all there, and even the 4 year old was angelic! I sat with Mr. & Mrs. Ashley Westcott and their little Gwendolyn, and the Lyle Cottrells. After the verger's talk, I stood in the vestibule a few minutes, talking to different ones and many of

the cousins came up and said good-bye to me as to their hostess and said they had had a wonderful time. The Ashley Westcott's gave me a lift home.

I'm so happy that everything seemed to go well. I myself had

a glorious time every minute.

LETTER FROM DR. F. HOWARD WESTCOTT --- "Project S. S. Hope" August 1, 1962 From Peru came this letter, via air-mail to Boston.

"Dear Eleanor and Members of the Westcott Society.

Georgia and I are very sorry to miss this 14th biennial celebration. I well remember the one in Boston when Roscoe Whitman was

in his glory 30 years ago.

Georgia and I are very busy here in Trujillo, Peru, aboard the S. S. Hope ship. We go to Solaverry Belen Hospital five days a week for allergy clinics where we see patients from the wealthiest land owners to the poorest families who live in mud (barrio) walled huts often 7 or more to a family (no birth control here) and often no roof to the hut.

It has not rained here since 1925 and the 14 foot sugar cane is grown by irrigation from the Andes Mountains.

We are doing a wonderful work here and are trying to elevate

the standards of medical care to every one in Peru.

The people, mostly with Indian blood are very interesting, but

not very interested in bettering their plight.

We are well but begin to long for the U. S. A., especially for Tenafly. We leave August 9th and arrive home, after seeing more of South America, about September 1st. Have lots to show and tell you." Then in Peruvian he signs, "Good wishes to you all until later."

TRAGEDY AT BERLIN, NEW YORK --- Article by Eleanor Trismen

Many of us read on July 23rd about the tractor-trailer, loaded with propane gas, which ran down a hill, out of control and exploded in Berlin, New York, a small town in Rensselaer County, west of Albany, New York.

Since a number of the town residents are descended from Arnold Wescott, son of Stukley Westcott, of Cheshire, Massachusetts, I was so shaken with the details of the Berlin tragedy, that I wrote to my cousin, Phoebe Shubert. Phoebe wrote an eight page letter to me but said she herself was not of much help since she had just returned home from the hospital, but, her husband tried to help neighbors, the McCumber's who later died of burns. Phoebe said a window in their house was broken and a chair scorched.

The paper spoke about the death by heart attack of Mrs. Mabel H. Wager, 77 years of age. She was an Arnold Wescott descendant and a younger sister of Edith (Lewis) Simmons, who belonged to our Society some time ago.

The town is still in shock, Phoebe said.

The young man, Robert Bentley who was knocked off a ladder while painting, is a relative of mine on my grandmother Bentley family line.

While at Boston, I spoke to Rachel Cottrell, of Buskirk, New York a town quite near Berlin. She told me that most of the Berlin folks who were badly burned had died--a terrible tragedy!
