## NATIONAL SOCIETY NEWS - Reunion at Poultney, Vermont

Our 1964, 15th Biennial Meeting, held in Poultney, Vermont was a great success. Cousin Harold Wescott, President of the Vermont Chapter, Cousin Frances Reed, its Secretary, and all the Vermont cousins in and around Poultney are to be greatly commended not only for their fine hospitality, but for the time, thought, and effort they put into giving us all such a wonderful three days. Frankly, many of us wished we could stay much longer.

The Biennial Meeting started on Friday, August 7 with registration and an informal reception at the Foultney Valley Club, which the Vermont Chapter had worked hard to decorate very beautifully for the occasion. Informal refreshments were served, and there was much renewing of old acquaintance and meeting new friends. Later slides were shown of former Vermont meetings. For part of the evening the Executive Board had to tear itself away for its own meeting to determine Directors and certain matters of policy, which will be looked into more fully before final decision.

On Saturday, August 8 there was a business meeting at 10 A.M. at the lovely old Baptist Church in East Poultney. Miss Susan Westcott Handy, the continuing National Society President, presided.

The meeting opened with greetings from the Rev. Lewis Brehaut, the Church's Pastor, followed by a welcome to Vermont by Mr. Harold W. Wescott, President of the Vermont Chapter. Next came the Biennial reports, followed by the election of National officers for the next two years. The only change in National officers is in the Recording Secretary. We regret that Mrs. Lucius Hitchcock can no longer continue in that office, but we are sure that the new Recording Secretary, Mrs. Mabel L. Wescott of Bloomfield, Connecticut, will do a good job.

Following the business meeting came a very inspiring Memorial Service, under the direction of Mr. Webb Wilder, National Chaplain, assisted by Miss Louise Harris, National Registrar. The organ was played by the regular Church organist. The morning session concluded with an extremely interesting talk on "Historic Poultney" by Rev. Lewis Brehaut. Luncheon was served downstairs by the ladies of the Church.

At 2 P.M., after an opportunity to visit a small museum of antiques opposite the Church and another old Church on the "green," a large bus provided by Cousin Harold Wescott drove the Cousins to the Castleton Antique Car Museum, which revived many memories, and then over the State line to Whitehall, New York (the birthplace of the U.S. Navy), to see a larger museum of antiques, which also had models of the oldtime shipyard and ships built there. Whitehall was first called Skenesborough, for its founder, Major Philip Skene, but the name was changed in 1786 because it was thought "too British."

At 7 P.M. the Biennial Dinner was held at the Poultney Valley Club. The food was delicious, and we were told that "it was the largest turnout ever." After dinner there were greetings by the National President, Miss Susan Westcott Handy, and "The Story of Stukely Westcott" was read by the National Vice-President,

Mrs. Ralph D. Trismen. A few Westcott and other songs were sung; then the Cousins had the unexpected opportunity to see three very talented little Poultney girls perform the tap-dance and specialty dance routines which they had just returned from doing at the New York World's Fair. They gave a highly professional and very fine performance. Following this came general square dancing by the younger set.

On Sunday, August 9, there was a well-attended Family Gathering at 10 A.M. at the East Poultney Baptist Church for Sunday worship. This ended the official Biennial Meeting, but the Vermont Chapter had invited the National Society members to be their guests at the Vermont Chapter's annual meeting, picnic dinner, and song program - to be held at Cousin Harold Wescott's camp in Middletown Springs at 1 P.M. All who were not forced to start for home early were glad to accept, and had a very good time.

The place for the next Biennial Meeting in 1966 has not yet been decided. Both Iowa and upstate New York were mentioned, but nothing has been settled.

Dr. F. Howard Westcott was unable to be at the Vermont meeting, but sent a letter. His plan is still being worked out, and final details have not been determined. This will be looked into carefully.

Our National President, Miss Susan Westcott Handy, reported that since her election in Boston in 1962, she has tried to keep in close contact with the Chapters and to assist the officers as much as possible.

"In the spring of 1963, Joye Satterfield, Assistant Secretary-Treasurer, resigned. Joye and her family have moved to Park Ridge, Illinois, near Chicago. We were sorry to have her leave the Boston area. Dorothea Cogswell has carried on alone in the dual capacity of Corresponding Secretary and Treasurer. I am sure you all will agree she is doing a splendid job. Louise Harris as Registrar is likewise an enthusiastic officer. The Clerical work of the Society is, I feel, in very good hands. The Family should be very grateful to Dorothea and Louise.

"I regret we have not been able to reactivate the New York or Illinois Chapters. Only Rhode Island, Iowa and Vermont have regular meetings. Greater interest in the Family is aroused if a group of Cousins can assemble at least once a year. I am happy that the Rhode Island Cousins are meeting more often.

"The National Society was invited to attend a 'Forefathers' Service' on April 26, 1964, at the First Baptist Meeting House in Providence. It followed the order used in the Meeting House in the 17th Century - standing for prayer and sitting for singing. Afterwards a Colonial Tea was served in the Fellowship Rooms. I attended this most interesting service. As many of you know, this is the Church Stukely Westcott helped to organize, where we always have Sunday morning worship when we meet in Rhode Island.

"On July 11, my brother and I were hosts to the Rhode Island Chapter at a supper at our home. On July 25, I had a meeting at our home of the National officers living in Rhode Island and Massachusetts, to discuss matters to be acted on at the Executive Board Meeting in Vermont."

After quoting the section of our Constitution which names one of our Society's objects as the steadfast support and advocacy of "the defense and the protection of the Country which our ancestors helped create, and the preservation of the Constitution of the United States of America and the liberty of the American people," she quoted from Mr. Whitman's foreword in Volume I of his STUKELY WESTCOTT GENEALOGY, that our ancestors contributed simply and unostentatiously but earnestly and

successfully to the welfare and upbuild of America. She ended! "May we be worthy descendants of these brave ancestors, and by our endeavors help to restore and preserve the Constitutional government which they established."

The Vice-President, Mrs. Ralph D. Trismen, reported that although she was not called on to preside at any meetings, as our President, Miss Susan Westcott Handy, was able to serve, she still was quite busy getting the Westcott records in the mail to our Secretary-Treasurer, Miss Dorothea B. Cogswell, and to our Registrar, Miss Louise Harris. The Vice-President also keeps the Family Album up to date, adding all printed items of interest, which are sent to her after they have appeared in the Quarterly. She also read at the August 1964 gathering in Vermont, by request of our President, a paper she had written on the History of the first Stukely Westcott in America. She feels that all the officers newly elected in 1962 have done a fine job.

The Registrar, Miss Louise Harris, reported 3 regular members and 2 associate members added between August, 1962 and January 31, 1964, when the new officers started their term of office. From February 1, 1963 to August, 1964, there were 9 new regular members and 4 new associate members. Thus there were 18 new members added since the last Biennial Meeting.

The Corresponding Secretary, Miss Dorothea B. Cogswell, reported that from August, 1962 to the end of July, 1964, we lost 1 member by resignation, and had to drop 3 members for nonpayment of dues, while 8 were reinstated. (Three more reinstatements had come in during the first week in August.) Most reinstatements came from a July drive. Since the 1962 report, 9 members and 15 relatives of members have died.

As of July 31, 1964, a grand total of 543 regular memberships and 50 associate memberships had been issued over the years. Current regular plus associate members on July 31 totalled 218, with 3 more added in the first week of August.

Because the former Treasurer very kindly sent out the 1963 dues envelopes early, so that most dues would come to her, the present Treasurer, Miss Dorothea B. Cogswell, reported the following:

It was voted to accept the Board of Directors' three recommendations.

## ITEMS OF INTEREST

Miss Olive Wescott, a former National member, retired on May 24, 1964, after 56 years of teaching in the Sumner, Iowa school system, where she taught the second grade. In a brief ceremony in her classroom on the final day of school, the Superintendent of Schools presented her with a certificate and a pin acknowledging her 56 years of teaching, and thanked her for the many devoted years she had given her chosen profession. The President of the Board of Education gave her a booklet expressing the Board's appreciation, along with 56 silver dollars - one for each of her teaching years. She was also given a scrapbook containing the names and pictures of hundreds of her students. The final gift, a gold watch, was presented by the Sumner Education Association.

The editor of the local paper, one of her former pupils, wrote of her:
"Teaching in grade school is not just a matter of presenting material to be learned and hoping that the children absorb some of the presentation----It's the overall impression which is left on that child -----which remains after 20 ---or 30---or even 50 years.---You'll never forget that the second grade was a warm and wonderful world all its own, guided by a quiet-voiced woman who knew how to make a story come to life, who made such things as Indians and Pilgrims come alive in your mind's eye.---She believed in teaching her children respect for God, for their Country, their ancestors, their school, and the first awakening of the need for respect for their fellow men.---She has had a profound influence on this community during these years. --- I can only wish her many pleasant years.----May her retirement bring her happiness, contentment, and a realization of accomplishment."

All her Westcott Cousins join in this wish. We thank her sister-in-law, Mrs. George Wescott, for sending the newspaper clippings, which will be placed in the Family Album.

In April, 1964, Mr. William G. Wescott of Genesee County, N. Y. was one of the first three Genesee County probation officers to complete two in-service training programs on basic orientation and principles and methods in probation offered by the State Correction Department. The two 5-week courses were given in Rochester and Niagara Falls - a total of 10 weeks in all. This is part of a statewide program, with courses in various cities.

Early in 1964, Mr. Ralph M. Westcott of Los Angeles, California, then president of Holladay & Westcott, consulting engineers, was appointed as Executive Director of the Consulting Engineers Association of California (CEAC). He thereupon became Chairman of the Board of Holladay & Westcott and obtained a leave of absence to take his new post. He had served as President of CEAC in 1956 and 1957. In 1956 CEAC joined nine other consulting engineer associations in forming the national Consulting series of expansion moves of the association.

Cousin Minita Westcott Trainor Shrewsbury, whose business name is Miss Minita Westcott, announced as of July 1, 1964, a reorganization of her company, Storms and Westcott, through incorporation and addition of top level executive personnel. The firm of Storms and Westcott was founded in 1949 as a partnership with North Storms, an outstanding leader in the association management field, and after his death was continued by Miss Westcott as a sole ownership for the past twelve years.
