NATIONAL SOCIETY NEWS

The Rhode Island Chapter of the Stukely Westcott Descendants of America decided at its meeting on April 26 that the National Meeting will hold its Registration at the Holiday Inn, South Attlebore, Mass., Friday evening, August 16, 1968, at 7-9 P.M.

This Holiday Inn is at the junction of Routes 1-95 and U.S. 1-A. The address is 1270 Newport Ave., South Attleboro, Mass. 02703. The Innkeeper is Andrew H. Jackson the phone no. is 617/761-6660. The HOLIDAY INN PASSPORT (the booklet about all Holiday Inns) lists this Inn as having 180 rooms. Reservations may be made either by writing or phoning the Innkeeper, or by phonung any Holiday Inn, which will make a free advance reservation at the desired Inn through its computerized reservation system. This reservation will hold rooms until 6 P.M. on the stated day. Anyone expecting to arrive after 6 P.M. can prepay the reservation by check to the designated Inn or the Inn where the reservation is made, which will forward the check to the Inn where the reservation has been placed. Another method of prepayment is to charge the room cost to your Gulf Travel Card, British-American Oil Co. Ltd., American Express, or Diners Club credit card. Or a reservation may be held after 6 P.M. by guaranteeing payment. Then if you do not arrive by your specified time (or 'all night"), your room will be freed for sale to someone else; but if it is not sold to someone else, you will be billed for it. If your plans change after making reservations, just phone any Holiday Inn, tell them where you hold reservations, and ask that the room be released. This can be done at any time up to 6 P.M. of the designated day. Rates vary between Inns and according to seasons. The new booklet (June-September) lists the South Attleboro rates as: 1 person - 1 bed \$11 - 2 beds \$13 2 persons-1 bed 16 - 2 beds 18

There is also a charge of \$2 for any extra person in a room, and a Mass. Tax of 5%.

On Saturday morning, August 17, we shall hold our Memorial Service, Business Meeting, and lunch at the Slater Mill Museum in Pawtucket, R.I. More complete plans for the day will be announced in the July Quarterly. In the afternoon we shall have a clambake at Cousin Susan Handy's lovely home in Manville, R.I., instead of a banquet.

Luncheon will be "on our own", with eating places to be suggested later. Sunday afternoon we shall visit the Stukely Westcott memorial in Warwick, R.I. Then Cousin Louise Harris will show us the truly amazing museum she has created in her home from YOUTH'S COMPANION memorabilia, and especially of everything possible connected with C. A. Stephens, who wrote for so many years the always-delightful "Old Squire" stories in the YOUTH'S COMPANION, along with writing many other series for many magazines. At the annual meeting in April of the R.I. Society of Mayflower Descendants Webb W. Wilder of Johnston, R.I., our National Chaplain and President of the R.I. Several Cousins sent newspaper clippings about "Clint" Wescott, aged 51, of Los Angeles, pfofessional bum for 15 years, bearded and tattered, with 44 cents in his pocket, who accepted a dollar bill from a reporter but refused to accept a letter telling him that he had \$19,219.68 waiting for him in two New York bank accounts. For those who missed the item, Clinton Wescott was originally a popular, industrious resident of Burnt Hills, N.Y., his lifelong home. He built his gas station with his own hands. "Suddenly one day 15 years ago he said: 'To hell with it!' and took off," according to the Burnt Hills attorney, John P. Brown, who had been searching for him since that legal firm was appointed in 1961 by the N.Y. Supreme Court to handle the case. The money came from a foreclosure sale of the gas station in 1961. When Clinton Wescott could not be found, the N.Y. Supreme Court ordered the \$15,124 due him to be banked in his name. Accumulated interest has now brought the amount to \$19,219.68. But "Clint" Wescott likes his present life with "no cares" and almost no money in his pocket.

Your Editor asked a lawyer cousin what would become of the money if "Clint" Wescott continued to refuse it, and was told that unless there were other immediate heirs, it would revert to New York State.

1. Tombstone Memorial Plaque: at \$32.00 each, in Bronze, measuring about 6"x9", with 4 screws to fasten on stone. The plaque includes our Coat-Of-Arms, person's name and Society name. Each plaque is made up individually.

2. Wall Plaque: Westcott Coat-Of-Arms now \$20.00 each, suitable for hanging on wall, measuring about 5"x 7", in Bronze mounted on walnut with chain for hanging.

Cousin Hanson C. Wescott of Ypsilanti, Mich. wrote in February that his wife, Eleanor, keeps busy with her position as Supervisor of the Cash Office at the Montgomery Ward Company in Ann Arbor. He himself has retired from Aviation work and now looks after the 4 apartments (housing 13 Eastern Michigan University co-eds) in his home. (This sounds like a full-time job.)

Cousin Myrta Grace Paugh has found the Westcott name twice in her research into DeLand history. Once in the early 1900s a Westcott couple from St. Louis visited the Methodist pastor in DeLand. Also not too many years ago the obituary of a former Christian preacher, L.A. Crown, stated that his mother had been a Westcott. Cousin Grace is very busy now on the County history, to finish it before Illinois' Sesquicentennial year is over.

Will any other descendants of Daniel Westcott of Southern New Jersey, who married Deborah Smith, please get in touch with Miss Myrta Grace Paugh, DeLand, Ill. 61839, to check the line of descent? She was descended from their son Leonard. Her records say that this was Daniel 4 (of Richard 3, John 2, Richard 1 of Conn.) But a Florida cousin who wrote her claimed to be descended from this same Daniel's son Richard, and she believes that this Daniel 4 is of Daniel 3, Daniel 2, Richard 1 of Conn. Daniel 4 and Deborah (Smith) Westcott had 5 sons - Richard, Leonard, Thomas, Zeba, and Arthur. Has anyone done any research to straighten out this line?

Cousin Elizabeth Wescott (Miss Elizabeth M. Wescott, 495 Main St., House #10, Apt. 1-A, Orange, N.J. 07050) needs help in tracing her line farther back than her great-great-grandfather, George Wescott, who was Treasurer and Deacon of the Old First Baptist Church in Philadelphia. At the Crozier Library, Baptist Seminary, Chester, Pa., she copied these old Philadelphia church records, which mentioned that some of the church meetings were held at George Wescott's home. His Family Bible says that George Wescott, the Coppersmith of Philadelphia, was born 5/7/1713 (no place listed), died Philadelphia 7/28/1781. According to Philadelphia tax records, he was worth \$150,000 at his death. Cousin Elizabeth is looking for the names of his parents and the place of his birth.

Cousin Elizabeth also writes that our late member, Mrs. Harry (Edna Wescott) Houghton of Washington, D.C., had said she had an ancestor named Ocean Wescott (because born at sea), who came into the port of Philadelphia. Cousin Elizabeth would like to have ideas about George Wescott's parentage and birthplace.
