Sept. 5, 1887, son of George Washington Westcott and his 2d wife, Celia Ann Shoemaker. He was predeceased in 1967 by his wife, Mrs. Ethel D. Westcott, whose death was reported in the July, 1967 Quarterly. He was formerly of Hasbrouck Heights, N.J., but was living at the time of his accident in Daleville, Pa. He is interred in Hornbaker Cemetery, Madisonville, Pa. He is survived by a daughter, Mrs. Joyce Kerr, who was living in 1967 in Ridgewood, N.J., and by grandchildren and great-grandchildren. Cousins who knew him will regret his passing.

Harlow Ellingsrud, aged 55, died Dec. 25, 1968, at Edgerton, Wisconsin. ITEMS OF INTEREST

Mrs. Daphne M. Brownell received word recently that she passed the examination for record searcher and is duly certified by the Board for Certification of Genealogists, Washington, D.C. As she is preparing for publication a second book on her ancestors, most of her efforts for the time being will be toward this goal. However, she will search records for the County of Volusia, whose county seat is at DeLand, where she lives. A fee for searching will be expected. A letter forwarded by our former Secretary and President, Mrs. Ralph D. Trismen, from a Mr. Stephen Millett of 1694 31st St. N.W., Washington, D.C. 20007, makes a major correction in Stukely Westcott's marriage record. Mr. Whitman's Genealogy, Vol. II, p. 7, states: "Stucklie Westcott of Ilminster, and Julian Marchant of Yeovil, married 5 October, 1619." Mr. Millett writes: "Last November at my request the original Yeovil parish register, through the courtesy of the Vicar of St. John the Baptist Church, was examined at the Somerset Record Office by Mr. Shorrocks, the Assistant County Archivist, and Mrs. E. C. Hope of Cholsey, Berkshire, England. The entry was studied very carefully under an ultra violet lamp, and read as follows: 'Stuckley Westcott and Julian Marchante 5 October.' The words 'of Ilminster' and 'of Yeovil' simply do not appear in the entry. Since Mr. Whitman's papers were all destroyed, it is impossible at this stage to explain why he added the words 'of Ilminster'. Therefore it would appear that any further search for the ancestry of Stukely Westcott should not necessarily be confined to the Ilminster area."

In her reply to Mr. Millett, Mrs. Trismen quoted a written statement by Mr. Whitman that: "A deduction might be drawn that, after Westcott was married, he lived for a time in Yeovil, but after the birth of two of his children, he removed elsewhere, not distant from Yeovil and Ilchester, where his friends the Arnolds lived From the old Arnold papers it is learned that Westcott 'came from Yeovil or near there'. It is established that the Arnolds and Westcotts started for America from Yeovil - that the Arnolds were from Ilchester, and it is plausible to believe that Westcott was from a place not distant." Ilminster, Mrs. Trismen added, is about 15 miles from Yeovil, but its parish records before 1660 were destroyed by war. In 1955-6, while she was Secretary, the National Society hired an English genealogist to try to learn more about Stukely Westcott in England, including his parents' names but nothing new was found. She has always hoped that some interested Westcott might some day spend the necessary time and money to make a personal genealogical search of Somerset and Devon Counties. Sometimes when people know one is tracking down one's own family, they try harder to help. Let us hope that this may happen.

Mrs. Earl A. Westcott of Sylvania, Ohio (formerly of Cleveland), our member, last November won the top award in the annual recognition program for volunteers of the Greater Toledo Association's Red Cross Chapter. She had given 40 years of volunteer service in the blood-recruitment program. A very charming picture showing her receiving the award was printed in Toledo's paper, THE BLADE and will be preserved in our Scrapbook.

A brochure about the 2d and final printing of the first edition of the genealogy CREHORE AND KIN, by Amy H.B. Crehore Falcon, has been received by your Editor. "Lines of allied families, both men and women, are traced to the immigrant ancestor. Special attention is given to information relative to Historical Societies, with particular emphasis on lines to the Mayflower Pilgrims and the First Settlers of New

England. Included in this volume is a complete record, published for the first time, of all the gravestones in a small cemetery in Walpole, N.H., off the Old Keene Road to Surry and Keene. Also included is a previously unpublished solution of the General Equation of the Fourth Degree solved in 1859." The book has 286 pages, with a complete index of 4000 names. Only 100 copies were made in this printing - and now the plates have been destroyed. The book costs \$35, and has been bought by various public libraries and genealogical societies.

Mrs. Minita Westcott Shrewsbury of Chicago, our member, and one of the founders of the now inactive Chicagoland Chapter, last fall sold Storms and Westcott, Inc., the trade association management firm of which she was president. Articles in CHICAGO'S AMERICAN and the CHICAGO TRIBUNE Oct. 31 and Nov. 1, 1968, told how in 1926 she answered an ad for a secretary and North Storms selected her from over 250 applicants. This was the day he moved into Tribune Tower, which had been her headquarters ever since. She helped start organization management institutes, now held in universities throughout the country, and was the first woman chairman of the institutes' board of regents. She was the first woman president of the Trade Association Executives Forum of Chicago, the only woman president of the American Society of Association Executives, the only woman president of the National Institute of Organization Executives at Northwestern University, and the founder and first president, in 1965, of the Multiple Association Management Institute, of which she remains honorary president for life. In 1960 she received the Key award from the American Society for Association Executives - the industry's equivalent of an Oscar. After one week of leisure, she became Communications Director of the Architectural Aluminum Manufacturer's Association in Chicago. She plans more traveling for both business and pleasure, and hopes to see the Far East for the first time.

To her we say both "Well Done" for the past and an equally hearty "All Good Wishes" for the future.
