Harrison Russell Westcott of New Haven, Conn., aged 96, our oldest active

member, died Nov. 27, 1972, at a local convalescent home, where he had lived for several years. He was born Apr. 24, 1876, in Scituate, R.I., first child of Josiah Emerson and Frances G. (Russell) Westcott. He married Mar. 5, 1912, Mary Garfield Smith, daughter of John William and Margaret (Ferguson) Smith of Providence. She was born June 20, 1881, and died Nov. 20, 1963. He was for many years a civil engineer with the New York, New Haven & Hartford R.R., and helped plan the Providence Railroad Terminal in R.I. He was a member of the Harmony Masonic Lodge in Providence, R.I. The funeral service was held at the Beecher-Bennett Funeral Home, New Haven, Conn. Burial was in Pocasset Cemetery, Cranston, R.I. He is survived by his brother, Leslie P. Westcott of Providence, R.I., our member; 2 nieces and a nephew. Older members who remember him will be very sorry to learn of his passing.

Ashley Prince Westcott of Roslindale, Mass., our member, aged 76, died suddenly Jan. 25, 1973. He was born in Boston, Mass., Oct. 24, 1896, son of Edward Ashley and Florence L. (Prince) Westcott. In 1937 he married Miss Gladys Thomas, who survives him. He had been an oil burner salesman, and in his spare time was active in several amateur theatrical groups. After he officially retired from the oil burner business, he became a professional actor. He joined the Screen Actors' Guild and the American Federation of TV and Radio Artists. He played roles, including some speaking parts, in a number of movies filmed in Boston. In "Between Time and Timbuctu" he was listed in the cast as "The Deaf Juror." This movie was shown on National Educational TV in 1972. He also did some TV commercials. On the day of his death he was on location in Boston's "Combat Zone" for a film. He was also a volunteer driver for the Catholic Guild of the Blind, a volunteer worker at the West Roxbury VA Hospital, and a member of a Masonic Lodge in Hyde Park. Funeral services were held Jan. 29, 1973 at a Hyde Park funeral home, with the local Congregational clergyman officiating. Burial was in Knollwood Memorial Park, Canton, Mass. He is survived by his wife; 2 sons: David A. Westcott of Stoughton, Mass., and Richard T. Westcott of Pembroke, Mass.; a daughter, Miss Gwendolyn Westcott (a student at the University of Mass. in Boston); 2 brothers: Harold Westcott of Calif. (our former member), and Russell B. Westcott of Florida (our member); and 3 grandchildren. He was a vitally alive person, always doing something new and interesting. Those who remember him at meetings will miss him; and all will miss his interesting letters in the Quarterly

Dr. Richard Nutter Westcott, aged 54, our member, who had lived for some years at Lyndhurst, Ohio, died quietly at his home, March 10, 1973. He was born Aug. 7, 1918, the only child of our late members, Charles Hapgood and Hazel Louise (Nutter) Westcott. June 20, 1944, he married Miss Patricia Bosworth Ranney, who survives him. After serving in the Army Medical Corps in Europe during World War II, and in residencies from then to 1951, he joined the Staff of the Cleveland, Ohio Clinic in the Dept. of Internal Medicine and Cardiology, and became head of the Dept. of Electrocardiography. His wife writes: "These many years were very rewarding personally and professionally. He was devoted to his family and his profession. We saw all our three children grow to normal adulthood without the social problems of today, and gain good educations; and we gained two wonderful daughters through marriage. In the past 2 years my husband knew of his illness, but had respinded so well to treatment that he enjoyed a normal life - able to ski, sail with his family as crew, and attend medical meetings. Most important, many of his patients knew nothing about his limitations until 3 weeks before his death. He died quickly and quietly at home, without the suffering he might have known. His

family are very proud of his achievements, his courage, and of being part of his fine heritage." He is survived by his wife; his two sons: Mark Ranney Westcott, and Bruce Austin Westcott; and his daughter, Miss Anne Nutter Westcott. He will indeed be greatly missed.

Ernest Collins of Alamogordo, N.Mex., aged 78, brother of our former President, Dorothy (Collins) Perdue (Mrs. Harold L. Perdue) of Griswold, Iowa, died of a heart attack in January, 1973. He loved to attend the Iowa Chapter meetings, and will be greatly missed there. He was the last surviving brother of that family in that generation.

Charles Dwight Merrick of Pine Bluffs, Wyo., aged 59, brother of our members, Mrs. Edna Porter of Red Oak, Iowa, and Carlos Merrick of Menlo Park, Calif., died Apr. 29, 1973, at Laramie, Wyo. He was born in Allerton, Iowa, son of Fred and Mary Emma (Collins) Merrick. He was the nephew of our past President, Dorothy (Collins) Perdue (Mrs. Harold L. Perdue) of Griswold, Iowa. He graduated from the Elliott, Iowa Consolidated High School. In 1934 he married Miss Doris Huckfelt, who survives him. In 1963 when he moved to Pine Bluffs, he was a Federal Crop Insurance adjuster. He bought and ran the Sunset Motel, later built and managed the Traveledyn Motel. He was President of the Pine Bluffs Businessman Association, originated the Pine Bluffs Improvement Corp., and was on the Board of Directors of Merrick's, Inc. He was a member of the Grace Lutheran Church in Pine Bluffs, where memorial services were held for him on May 2, 1973. Funeral services were held for him the following day at the Lutheran Church in Torrington, Wyo. Burial was in Torrington Cemetery. In addition to his wife, he is survived by 3 daughters: Mrs. R.D. Pulatie and Mrs. Dennis Bruns, both of Pine Bluffs, and Mrs. Vincent Angel of Laramie; 2 sons: Jerry C. Merrick of Kailua, Hawaii, and Thomas D. Merrick of Pine Bluffs; 11 grandchildren; 3 brothers: Carlos R. Merrick of Menlo Park, Cal., Ray Merrick of Encinitas, Cal., and Paul Merrick of Scottsdale, Ariz.; and a sister, Mrs. Edna Porter of Red Oak, Iowa. He will be missed by those who knew him.

Your Editor has added a new quantity discount to lessen the gap between discounts for her FAMILY GROUP CHARTS OF ANCESTORS, which were written up fully in the last Quarterly. To summarize briefly: each chart is 11"x17", folds once to fit a 3-ring notebook, holds 5 generations of ancestors vertically, with full personal data, and has parentheses for ancestors' identifying numbers. All surnames run straight up, so are easy to follow. Lines can be continued indefinitely on later charts. Charts are on heavy white or pale yellow paper at same price (to let husband and wife have distinctive colors). Oehlers (Mrs. Edmund M.) of Millington, N.J. is Regent, won 1st Prize in the New Jersey Society of the DAR and 3d Prize in the National Society of the DAR for an illustrated lecture: "Somerset Hills in the 18th Century." James R. Bentley of Jeffersontown, Ky., at present our only Kentucky member, was elected Dec. 4, 1972, secretary of The Filson Club. This is a privately supported research library in the tradition of the American Antiquarian Society, the Mass. Historical Society, etc., with important collections in its own area. He is only the 5th man to hold this position since the Club's founding in 1884. He was born in Louisville, Ky., graduated from Eastern High School, and in 1964 received his B.A. from Centre College, Danville, Ky., where he was a member of Sigma Chi. He took his M.A. in American history at the College of William and Mary, Williamsburg, Va. In September, 1964, he came to The Filson Club as assistant to the curator, to arrange and catalogue the Kentucky newspapers in the Club's collection. The following June he left for Williamsburg, where he had received an apprenticeship in interpretation of historic sites, sponsored by Colonial Williamsburg and the College of William and Mary. On completing his apprenticeship, he joined the staff of the Research Dept. of Colonial Williamsburg in Sept. 1966 as a research assistant, and held this post until he returned to The Filson Club in January, 1968, as curator of manuscripts. He is a member of the Society of American Archivists and the Manuscript Society, and has represented The Filson Club at the Manuscript Society's annual meetings for the past two years. In February, 1971, he was invited to discuss acquisition policies and donor relations at the first annual Archives-Library Institute on Historical Research Materials sponsored by the Ohio Historical Society. In June, 1972, he delivered a paper on The Filson Club's genealogical collections to the Virginia Genealogical Society in Richmond. He is active in many historical and patriotic societies, and holds various official positions in many of them. The Filson Club History Quarterly, Jan., 1973, concludes: "It is a big task that confronts him, but he is uniquely qualified to handle it, and we have every confidence in the outcome."
