## NATIONAL SOCIETY NEWS

The twenty-fourth SSWD Biennial Meeting was held in Charlottesville, Virginia, Friday, August 6 through Sunday, August 8, 1982, hosted by Dorothy Whitman Potter, daughter of the Society Founder, Frances (Fran) R. Morris, and her husband, Edmund (Ned) Whitman Morris.

The gathering started at the Holiday Inn, I-64 & 5th St. with the Board of Directors meeting at 8:30 a.m. and concluded at 1:30 p.m. Folks from all over were arriving and preparations were under way for the evening banquet. Everyone was meeting old family friends and making new ones. At 5:30 p.m. the banquet room was ready with the help of our hosts with beautiful flower bouquets gracing the red table cloths. Punch was on tap while everyone was coming in and introducing themselves and signing the guest book.

At 6:30 p.m. Pres. Pauline Clark called the meeting to order. Invocation was by Mabel Wescott, with special music by Wilma Avery and Velma Reed. At the conclusion of the music, Pauline asked that starting to the right, cousins should please fill their plates from the buffet table at the back of the room. The table was covered with hot barbecued spare ribs, southern fried chicken, salads, vegetables, potatoes, rolls, ice tea and coffee. After everyone had finished their meal, apple and cherry pie was served.

Officers present for the meeting were President Mrs. Pauline Clark, Recording Secretary Mr. Sharon Coltey, Corresponding Secretary Mrs. Wilma Avery, Treasurer Mr. Paul Lewis, Registrar-Genealogist Mrs. Edna Lewis, Quarterly Publisher Mr. Edmund Morris, Directors Dr. F. Howard Westcott, Mrs. Mabel Wescott, and Mrs. Evelyn Hitchcock.

At 7:30 p.m. Pres. Pauline Clark opened the business meeting asking for a standing round of applause for our hosts for the outstanding job they had done in preparing for the 24th Biennial gathering. Pauline then presented a gift to Edmund Morris.

The "Pledge of Allegiance" followed. Pauline asked that each one stand and give their name and where they lived. Several spend the winter months in Florida that live in northern states so claimed two states. There were 39 present and 15 states represented from coast to coast and border to border.

Mrs. Mabel Wescott read the memorial service which had been prepared by Chaplain Mrs. Eulalia Wescott who was unable to attend. Scripture was from Revelation, Chapter 21, verse 4. Wilma Avery sang "Beyond the Sunset" with Velma Reed on accompaniment. Prayer followed by Mabel Wescott.

Sharon Coltey read the minutes of the 23rd Biennial Business meeting 1980 held at Bennington, Vt. They were approved as read.

Pauline asked for Corresponding Secretary's report which Wilma read as follows: 33 new regular members No. 666 - No. 698; four new associate members A66 - A68; 6 honorary membership certificates for 1981 and 9 honorary membership certificates for 1982 for members reaching their 80th birthday. Two new enrolled with one having passed away.

Pauline received a letter from Marion Dorfler explaining that she could not attend and Wilma received a letter from Eleanor Trismen on not being able to attend the gathering.

Pauline asked for Treasurer's report. Paul Lewis read his report with income of \$3,092.65, expenses of \$2,820.33. Balance in checking account of \$272.32, and in savings account \$309.74 for a total balance of \$582.06.

Pauline announced that the business meeting would conclude Sat. afternoon as the auditors, Mr. & Mrs. Bert Hoffman, had arrived this evening and had not gone over the treasurer's book and also the nominating committee had asked for more time to secure the necessary officers for the forthcoming two years.

Pauline asked for the Registrar-Genealogist report. Edna reported 39 new members including Associate Members and thanked everyone for sending her 'bits and pieces' of information which helps in connecting blood lines. She also reported on the Stukely Westcott marker in Warwick, R. I. and that Miss Ann Gallogly in the town office is overseeing the care of the marker. Edna also reported that chaplain Mrs. Eulalia Wescott had sent out 30 condolence cards.

Pauline asked Dr. Westcott to make two reports - Scholarship Fund and reprints of SSWD Vol. No. 1 & 2. Dr. Westcott reported that the fund was in good condition with four participants having completed their education. There are at present six receiving help. An application for one is being processed. An amount of up to \$1,250.00 a year may be applied for, at 5% interest. The fund is not large enough to give each student \$1,250.00 a year but does the best he can with it and has not had to turn anyone down. For all new applications though, the repayment time period has been changed from ten years to five years, after completing college, so that more students can participate. Anyone wishing to contribute to the fund may do so and they do not have to wait till they have a large sum as a lot of small ones will serve the same purpose. Send contributions to Dr. F. Howard Westcott, 16673 San Salvador Ct., Rancha Bernardo, San Diego, Calif. No. 92128. Dr. Westcott also reported that some funds were put in short term high interest investments of 15%. None of the students having received help or are receiving help have dropped out of school.

Dr. Westcott being Chairman of the Nominating committee requested anyone that was interested in helping the society please let him know as a meeting only once every two years does not allow the committee time enough to know each individual and to approach the ones that would like to serve.

Dr. Westcott cautioned everyone about buying Genealogical books advertised through mail services as they more than likely contain only a telephone listing of your name with no genealogy connection. There were only two sets of hard bound copies left of the SSWD reprints in June when Iowa held their chapter meeting.

Pauline asked Edmund to give a report on the Quarterly and Edmund asked only that he was sending out a plea to all cousins to send information to the News Compiler, on deaths, weddings, births and anything that you would like your cousins to know.

Pauline announced that each chapter will be required to submit a name to serve on the Board that are not officers in their own chapter but a person that will help in getting news to the quarterly through the News Compiler and also strengthening the Society. They are appointed by Pauline for a two year term. She announced the appointment of two new board members - Virginia Sampson of N. H. and Pattie Rochette of Kan. Also she brought before the members the reactivation of old chapters such as New York-New Jersey, Northern N. Y. and others that have become inactive. Mr. Hoffman asked for a list of Florida Stukely Westcotts and that a possible corresponding chapter could be formed there. Edmund responded that he would supply names and addresses for those interested in either reactivating or starting new chapters. Pauline said the requirement for a new chapter was five registered national members. She also announced a new chapter and asked Wilma to read it. Wilma said that on Aug. 5, 1982 an application was submitted with the following names: No. 8 Dorothy W. Potter, No. 10 Edmund W. Morris, No. 219 Sylvia Martin Uthe-Ramsing, No. 654 Allan E. Boerker, No. 682 Joan-Harvey Morris Bentson and was signed by the President. The new chapter was Chapter 13 of Virginia.

Pauline brought before the members a coat of arms reproduced by her son from the original. The  $8\frac{1}{2} \times 10$  for \$3.00 and  $4\frac{1}{4} \times 5$  free with the purchase of large one. New member gets one free. Information on availability of coat of arms will be published in an upcoming quarterly.

Pauline announced the dues would be raised starting Jan. 1983. Dues for family, from \$4.00 to \$5.00, and for individual members from \$2.00 to \$3.00. Non members who receive Quarterly only, would be \$5.00.

Pauline asked the Nominating Committee to stand--Dr. Howard Westcott, Wilma Avery, and Fran Morris. Dr. Westcott will be leaving the board this year and Pauline appointed Evelyn Hitchcock to the committee.

Pauline announced that the next board meeting would be in early August 1983, in Rhode Island.

Pauline presented Mrs. Mabel Wescott with a pillow as out going president with a picture of a frog. She presented Sharon Coltey with a note holder for his retirement from the board and Evelyn Hitchcock was presented a flower holder for her help for the last two years.

Wilma announced that a letter of gratitude was sent to Eleanor Trismen for her work on the Quarterly.

A question was asked on how many chapters the society had and Pauline turned it over to Wilma who read off the chapters as follows: No. 1 Central New York-Inactive, No. 2 Rhode Island-Inactive, No. 3 Greater New York-Inactive, No. 4 Northern New York-Inactive, No. 5 Vermont-Active, No. 6 Southern Michigan-Inactive, No. 7 Chicago Land-Inactive, No. 8 Abington, Pa.-Inactive, No. 9 Iowa-Active, No. 10 Cleveland, Ohio-Inactive, No. 11 New York-New Jersey-Inactive, No. 12 New Hampshire-Active, No. 13 Virginia-Active.

Mr. Edmund Morris made announcements concerning the following days activities. The meeting was adjourned at 9:00 p.m.

Pauline called the business meeting back to order at 6:30 p.m. Sat. and asked for the auditors report. Mr. Bert Hoffman reported the Treasurer's report to be accurate. Pauline reappointed Mr. & Mrs. Bert Hoffman as Auditors for the next two years.

Pauline called on Dr. F. Howard Westcott to announce the new slate of officers. Dr. Westcott read the following names:

The town offices of Warwick are located at 1515 West Shore Road, at the same site as the Westcott Marker. Miss Gallogly ordered a memorial wreath and placed it at the base of the boulder holding the bronze Westcott plaque in May 1981. Money was sent to her by the treas., amt. \$22.50. In May 1982 Miss Gallogly was able to have 4 red azalea bushes planted at the base of the Marker at a cost to the Society of \$25.00. She sent pictures with her reports each year. The Stukely Westcott Memorial Marker means a great deal to the people of Warwick, RI. Mayor Joseph Walsh is very proud to claim Stukely Westcott as an orginal proprietor of his town of Warwick.
